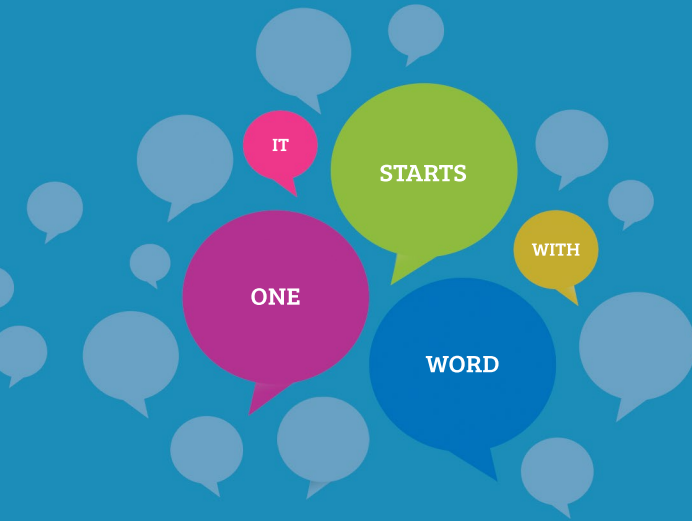

## ➤ About the Presenter



Debra Goshulak works with children with severe motor speech disorders at The Speech and Stuttering Institute. She has participated in numerous research studies and has presented on motor speech disorders at community, provincial and international conferences. She is currently involved in The Speech & Stuttering Institute's provincial initiative to train clinicians in the assessment, identification and treatment of children with motor speech disorders. Debra also regularly instructs PROMPT workshops.

## ➤ Workshop Summary and Outcomes:

This full day workshop will present a motor based approach for the assessment and treatment of children's motor speech disorders. The focus will be on the development of effective and meaningful goals, vocabulary selection, therapy techniques, session and activity planning and involving parents.

The purpose of the workshop is to provide speech-language pathologists and communication health assistants with practical treatment ideas for children with motor speech disorders. Many of the ideas are also applicable to therapy for children with other types of speech sound disorders.

## ➤ Learning Objectives

By the conclusion of this workshop, participants will understand:

1. The differences between dysarthria, childhood apraxia of speech and other speech sound disorders
2. How assessment information is used to develop goals and goal progressions
3. How to select target vocabulary based on goals
4. Cueing strategies to improve speech production accuracy
5. How to use motor learning principles in therapy
6. How to use books to target goals and set a theme for therapy sessions
7. How to develop roles for caregivers so they can support home practice
